WRITING A NEWSLETTER AIN'T EASY

One of the purposes of this newsletter is to report legislation that will have an impact on the DAV and DAV members - and it isn't easy. How can you report the facts without reporting the flaws. How can you report the flaws without seeming to be partisan.

Consider the horrendous condition the economy is in and the negative impact it has had on us, our children and even our grandchildren as the President and the Congress ignore reality and spend our future away on growing the size of the government bureaucracy and on every pork barrel dream the Congress has ever had. They dither over "Don't ask, don't tell" and making illegal aliens "legal" while ignoring the very real conditions that lead to the financial crisis. They give themselves and everyone in the government hefty pay hikes while doing nothing for the retired and disabled folk on Social Security and VA Disability pensions who will get no COLA for the second year in a row due to a negative CPI. Both political parties point the finger of blame at each other while helping each other to get more for themselves and the special interests they serve. In 2008, lobbyists spent 3.3 billion on Congress - that's more than 6 million per year each for all 535 members of Congress.

All of us served our country and paid a price through our disability. Many of us put 20 or 30 years into the military and retired with honor. Many of us have worked all of our lives and have paid into Social Security, SSI and Medicare. Many of us are still working with an expectation that we will get what is due to us when we retire. Yet all of that is in doubt.

A presidential commission has suggested many cuts to "entitlements" while I have not seen one serious recommendation to cut government or government spending. Recommendations to cut costs by privatizing the VA medical system and by increasing Tricare premiums are surfacing on a regular basis. Meanwhile, there has been no COLA increase for the past two years, saving the government tens of billions of dollars which the Congress immediately spent on "earmarks".

When the government has cut itself to the bare bone and has reduced spending to the point where it hurts, I will be ready to listen to them about cutting my "entitlements" - until then, I will fight them tooth and nail to keep what is rightfully mine and then to secure a future for my grandchildren.

Ronald Reagan said "Freedom is never more than one generation away from extinction. We didn't pass it to our children in the bloodstream. It must be fought for, protected, and handed on for them to do the same." He was right!

NEW PROGRAM SPEEDS
APPROVAL FOR VIET VETS

The VA has decided more than 28,000 claims in the first six weeks of processing disability compensation applications from Vietnam Veterans with diseases related to exposure to the herbicide Agent Orange.

"With new technology and ongoing improvements, we are quickly removing roadblocks to processing benefits," said Secretary of Veterans Affairs Eric K. Shinseki. "We are also conducting significant outreach to Vietnam Veterans to encourage them to submit their completed application for this long-awaited benefit."

Veterans who served in the Republic of Vietnam and who have been diagnosed with Parkinson's disease, ischemic heart disease, or a B-cell (or hairy-cell) leukemia are now eligible for health care and disability compensation benefits.

Vietnam Veterans covered under the new policy are encouraged to file their claims through a new VA Web portal at www.fasttrack.va.gov. Vietnam Veterans are the first users of this convenient automated claims processing system.

If treated for these diseases outside of VA's health system, it is important for Veterans to gather medical evidence from their non-VA physicians. VA has made it easy for physicians to supply the clinical findings needed to approve the claim through the new Web portal. These medical forms are also available at www.vba.va.gov/disabilityexams.

The portal guides Veterans through Web-based menus to capture information and medical evidence required for faster claims decisions. While the new system currently is limited to these three disabilities, usage will expand soon to include claims for other conditions.

VA has begun collecting data that recaps its progress at www.vba.va.gov/VBA/agentorange/reportcard/index.html.



THE SILVER STAR



The Silver Star is the third-highest military decoration that can be awarded to a member of any branch of the United States armed forces for valor in the face of the enemy.

The Silver Star is awarded for gallantry in action against an enemy of the United States not justifying one of the two higher awards - the service crosses (Distinguished Service Cross, the Navy Cross, or the Air Force Cross), the second-highest military decoration, or the Medal of Honor, the highest decoration. The Silver Star may be awarded to any person who, while serving in any capacity with the armed forces, distinguishes himself or herself by extraordinary heroism involving one of the following actions:

- * In action against an enemy of the United States
- * While engaged in military operations involving conflict with an opposing foreign force
- * While serving with friendly foreign forces engaged in an armed conflict against an opposing armed force in which the United States is not a belligerent party

CONGRESS WANTS TO CUT YOUR BENEFITS

The Congress has spent trillions of dollars over the past few years for “stimulus” packages, government growth and pork barrel projects, that has knocked the economy to its knees and placed the United States in debt to the tune of 14 trillion dollars. The economy continues to nose dive and there is no more money for Congress to borrow and spend, so they must now start cutting back. Rather than cut the size of government and their pet pork barrel projects, the Congress has been focusing on entitlements such as Social Security, Veterans Benefits and other entitlement programs while ignoring the behemoth, money sucking government bureaucracy they have created.

You can fight back by letting your Senators and Representative know that you will not support them if they vote to cut your benefits before they cut government and government spending to the bare bone. Cut government, not benefits to people who have earned those benefits through hard work and sacrifice. Our financial life and the economic future of our grandchildren is at stake and must be protected.

The letter is the most popular choice of communication with a congressional office. If you decide to write a letter, here are some helpful suggestions that will improve the effectiveness of the letter:

Make it legible and neat. Legible handwritten letters and well-typed letters are both effective.

Think about your letter as having three paragraphs, or parts.

The opening part should clearly state your position and why you hold it. Urge the Member of Congress to take specific action (e.g. vote for/against a particular bill or amendment; co-sponsor a bill; etc.) The second part should give more information on the bill/action in question and evidence supporting your position. The third part should be a brief summary and provide final encouragement. When possible, somewhere in your letter you should also try to thank your Member for some action they've taken in the past.

THE CHRISTMAS PARADE

On December 5th Chapter 57, once again, fielded the largest veterans contingent in recent years in the Taunton Christmas parade. We had the Chapter Banner carried by "Princess" Cassidy-Rose Crossman and Jack Crossman. This was followed by members Bruce Crossman, Ferdinand Medeiros, Greg Sullivan and JVC Bill Laliberte tossing out salutes, candies and holiday greetings.

They were followed by the Taunton High School Air Force Junior Reserve Officers Training Corps providing color guard service for Chapter 57. Cadets Christopher Baptiste, Elizabeth Curt, Zachary Ostenson, Robert Sampson and Kameron Westcott preceded the Chapter's five vehicles, bearing the National Colors, State and Chapter flags and escorting rifles. CDR LeRoy Crossman and PCDR Mort Morin led a five (5) vehicle cavalcade, furnished by the Metro Motor Group, containing Terry Akika, Walt Campbell, John Fielding, Jim Gray, Mike House, PCDR Ed Nunes, Dan O'Connor, Abe Haynes and Norm Record. This band of scruffy characters emulated our marchers by passing out their own holiday greetings, salutes and goody distribution.

Our rear guard consisted of two (2) Ford pickups with 2,000 toys and games furnished by Metro Motor Group's Vice President Domenic R. Grieco. Mr. Grieco was assisted by his father and almost a dozen of his employees in walking the parade route passing out their largess. This is a repeat performance that Metro Motor has provided for a number of years. Actually, without their contribution it is doubtful if we older folk would be able to participate in the Middleboro and Taunton parades.

OTHER THAN HONORABLE DISCHARGE

Veterans advocates say there is a troubling trend within the United States' fighting force: increasing numbers of service members discharged from duty for misconduct and other disorders who are suffering from the mental wounds of war. Once dismissed under other than honorable (a.k.a. Bad Paper) discharges, many find themselves unable to get the help they need for mental health issues that might have sparked the misconduct. Veterans' advocates see cynical forces at play in the use of administrative discharges for reasons including misconduct, personality disorder and adjustment disorder — defined as an excessive reaction to a stressful event, with symptoms similar to PTSD.

Some Vets Advocates concerned about military's adjustment disorder discharges report: "The military has been discharging troops who are suffering from combat stress, instead of providing treatment." That would mean that many" who have been discharged for "adjustment disorders" but who "could be afflicted with mental health conditions, including post-traumatic stress disorder and traumatic brain injury, have left the service without official medical diagnoses and no chance for medical benefits." After several attempts to get discharges data from the Pentagon, four Senators called on Defense Secretary Robert Gates in a letter last week to pry the information loose." The article went on to state that many of the soldiers who received Other Than Honorable Discharges had served multiple tours.

MORE ENTITLEMENT CUTS SUGGESTED

The President’s National Commission on Fiscal Responsibility and Reform co-chairs, former Sen. Alan Simpson (R-Wyo.) and former chief of staff to President Clinton, Erskine Bowles, released a 58 page initial plan which includes the following military pay and benefit related proposals:

A Federal Pay Freeze – The plan’s most volatile suggestions is a three-year military and federal civilian employee pay freeze. In general, the freeze would affect basic pay and basic allowance for housing (BAH).

Eliminate the 20 Year Military Retirement – The plan calls for replacing the current 20-year retirement system with a plan that would allow retirement at 10 years but delay payment until age 60. This would presumably affect future military entrants.

Reform COLA – The panel suggests making the military retirement/annuitant and disability compensation annual cost-of-living adjustments formula reflect consumer shopping options – essentially reducing the annual increase.

Increase TRICARE Premiums and Co-pays — Premiums and fees would climb for working-age military retirees, enrollment fees and co-pays would be applied to all three TRICARE options, including fee-for-service coverage under TRICARE Standard and the preferred provider network using TRICARE Extra.

In addition, employers would have to reimburse the government for any military retiree who opts to use TRICARE over employer offered programs.

DON’T ASK. DON’T TELL

Following earlier action by the House of Representatives and the Senate to end “don’t ask, don’t tell”, President Obama plans to sign the bill to repeal the ban called on openly gay service before the end of the year 2010,

In letters to the troops over the weekend, the four military service chiefs warned that the ban is still in place, and will be for some time to come.

There will be no public displays of affection, no separate bathrooms, no harassment and no special treatment for any members of the United States Armed Forces.

As the U.S. military begins to map out how it will implement the new edict allowing gays to serve openly, the first order of business is drafting the regulations. The rule changes under discussion won't dictate how troops feel about the change, but will strictly enforce how they act on it.

DAV CHRISTMAS PARTY

A fine time was had by everyone who attended the annual DAV Christmas party.

Medical Insurance Cuts Delayed

Medicare and TRICARE payments to Doctors were set to be cut by 25 percent on January 1, 2011. Congress has postponed the pay cut until January 1, 2012 - the latest of several such delays this year. But this has not addressed the issue. Many feel

DID YOU KNOW

In the Armed Services, a military cadence or cadence call is a traditional call-and-response work song sung by military personnel while running or marching. In the United States, these cadences are sometimes called jody calls or jodies, after *Jody*, a recurring character who figures in some traditional cadences.

As a company was returning from a long tedious march through swamps and rough country, a chant broke the stillness of the night. Upon investigation, it was found that a soldier by the name of Willie Duckworth, on detached service with the Provisional Training Center, was chanting to build up the spirits of his comrades.

It was not long before the infectious rhythm was spreading throughout the ranks. Foot weary soldiers started to pick up their step in cadence with the growing chorus of hearty male voices. Instead of a down trodden, fatigued company, here marched 200 soldiers with heads up, a spring to their step, and happy smiles on their faces. This transformation occurred with the beginning of the Duckworth Chant.

Upon returning to Fort Slocum, Pvt. Duckworth, with the aid of Provisional Training Center instructors, composed a series of verses and choruses to be used with the marching cadence. Since that eventful evening the Duckworth Chant was made a part of the drill at Fort Slocum as it proved to be not only a tremendous morale factor while marching, but also coordinated the movements of close order drill with troop precision.

This original cadence was recorded as "Sound Off:"
Sound-off; 1 - 2; Sound-off; 3 - 4; Cadence count; 1 - 2 - 3 - 4; 1 - 2 — 3 - 4.

This cadence, known as the "Duckworth Chant," exists with some variations in many different branches of the U.S. military. Duckworth's simple chant soon was elaborated by folk tradition among Drill Sergeants and the soldiers under their command, and the tradition of creating elaborate marching chants or songs spread to other branches of the military

Gulf War Veterans' Illnesses

VA's Gulf War Veterans' Illnesses Task Force issued its final report, which details how VA will improve medical care and services for Veterans of the 1990-1991 Gulf War.

Some of the recommendations outlined in the report are:

- Improve the delivery of benefits to Veterans with Gulf War-related disabilities.
- Expand training for VA benefit examiners on how to administer disability claims with multiple known toxin exposure incidents.
- Find new treatments for Gulf War Veterans through new research.
- Enhance outreach to provide information and guidance to Veterans about benefits and services available to them for injuries and illnesses associated with Gulf War service
- Improve VA health care for Veterans through a new model of interdisciplinary health education and training.
- Increase number of long-term, Veteran-focused studies.
- Transition from reactive to proactive medical surveillance to help better manage Veterans' potential hazardous exposures.
